The Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed deposit receipts towards EMD should be in favour of **Accounts Officer (Cash), O/o CGMT, BSNL, Jaipur.****
5. Those contractors not registered on the website mentioned above are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
6. The intending bidder must have valid class III **digital signature** to submit the bid.
7. On opening date the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Contractor can upload documents in the form of JPG format/ PDF format.
9. **Contractor must ensure to quote rate of each item. If any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" Zero.**
10. The Financial bids shall be opened for the bidders whose bids qualify for the same based on the mandatory documents (Technical Bids) uploaded online during e-bidding process and Originals of cost of tender document and EMD submitted physically in the office of **Executive Engineer (Civil), Jaipur** on or before the due date as per the terms and conditions of the NIT and the decision of the tender opening authority shall be final and binding.
11. **Conditional tender shall be rejected.**
12. SC/ST contractors enlisted under class-V category are exempted from processing fee payable.
13. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criteria.
14. The intending bidder shall have to associate specialized agency of furniture / modular partition & work stations of respective class for execution of furniture / modular partition work.
